ACADEMIC COOPERATION AGREEMENT

Between **Novosibirsk State
Technical University**

And

OTH Regensburg

Hereby, the **Academic Cooperation Agreement** (hereafter referred to as the **ACA**) subscribed by on one part **Novosibirsk State Technical University**, represented by its Rector Prof. Dr. Anatoly Bataev , hereafter referred to as **NSTU**, and on the other part, **OTH Regensburg** represented by its President, Prof. Dr. Wolfgang Baier referred to as **OTH.R** in the following terms and conditions.

I. PURPOSE

Recognizing the mutual benefits to be gained through a cooperative program promoting scholarly activities and international understanding, **NSTU** and **OTH.R** enter into this **ACA**.

II. TERMS OF THE ACA

The above mentioned universities agree to the following forms of cooperation:

- Exchange of research and teaching personnel.
- Development of collaborative research projects.
- Organization of joint conferences, symposia and seminars.

III. IMPLEMENTATION

1. Cooperation projects under this **ACA** may include any academic disciplines of **NSTU** and **OTH.R**. Either party may initiate proposals for activities under this **ACA**.
2. The visiting person will cover all costs (which shall include transportation, housing, meals, and all other living expenses, unless otherwise specified for any particular case). In addition, the visiting person shall contract an international health

insurance valid through all the duration of the exchange. The duration of the stay will be agreed upon in advance by both parties.

5. The exchange of scientific staff shall be realized on the level of the Faculty or Department interested in such cooperation.

IV. COORDINATION ACTIVITIES

1. The responsible persons for executing this **ACA** are:

- Vadim Nekrasov, Vice-Rector for International Relations
(NSTU)
- Prof. Dr. Wolfgang Baier, President (OTH.R)

2. International Relations Offices at both institutions shall be responsible for evaluation of the activities under this **ACA**.

V. VALIDITY

This Agreement shall become effective upon the signature of both parties. The Agreement is valid for the period of four (04) years and is automatically renewed for the same period if no party wishes different.

VI. TERMINATION

Either institution may resolve this **ACA** with an anteriority of no less than 3 month's notified notice. In case of resolving the agreement the parties must conclude any assignments pending of completion.

VII. APPLICABLE REGULATION AND COMPETENCE

In case of any discords or controversies that could arise out of this **ACA**, including those of its nullity or invalidity, the parties will solve it by a common and friendly agreement or they would submit it, to the competence that both parts consider advisable.

VIII. OTHER TERMS

1. This Agreement is prepared in English in two identical copies, both with the same legal force.

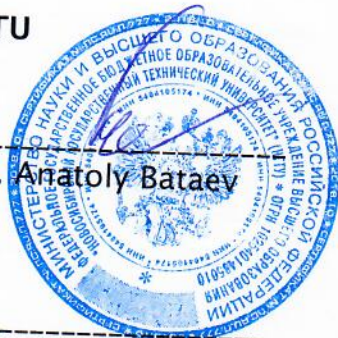
